6. The Bids will be open in the presence of Bidder's representatives who choose to attend at 2:00 PM on the 2078/08/16 at the office of Tribeni Rural Municipality. Bids must be valid for a period of 120 days after bid opening and must be accompanied by the bid security of scanned copy of the bid security in pdf format in e-Bidding, amounting to a minimum of following amount which shall be valid for 30 days beyond the validity period of the bid.

7. If the last date of purchasing or submission falls on a government holidays, then the next day working day shall be considered as the last date. In such a case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

8. Bidders bid by E-bidding system; bidders within the specified time shall be considered as non-responsive and may cause forfeiture of bid security.


